Vidyalaya Jorhat held on 10.3.74 and passed unanimously as follows:- "Resolution No-3 - "with the permission of the chair, as per agenda the members present discussed about forming a Trust Board consisting of some trustees on whom all the properties of Rashtra Bhasa Vidyalaya will be vested for the purpose: set out in clause 3 of the Memorandum of Association of Rashtra Bhasa Vidyalaya and for that purpose to execute (P.T.O. continued 2. Murlidhar Baheti Askaran Jalan) execute the approved Deed of Trust and get this Deed registered and give delivery and possession of All the properties of Rashtra Bhasa Vidyalaya to the Trustees, and it is further resolved that the following persons shall be the Trustees:- 1. Sri Murlidhar Baheti S/o- Late Hiralal Baheti 2. Sri Madhab chandra Chakrabarty, S/o- Late Durgamohan Chakrabarty. 3. Sri Sardar Dewan Singh Rais. S/o- Late Tehel Singh Rais, 4. Sri Biharilal Lahoti S/o- Late Purnamal Lahoti, 5. Sri Badri Prasad Bayanwalla, S/o- Late Bulchand Bayanwalla, 6. Sri Moolchand Baid, S/o- Late Shree Chand Baid 7. Sri Askaran Jalan. S/o- Late Mahadeo Jalan.

Now This Deed of Trust witnesseth:- (1) That the name of the Trust shall be "Rashtra Bhasa Vidyalaya Trust of Jorhat" (P.T.O. continued 3 Murlidhar Baheti Askaran Jalan) (2) That all the immovable properties of the Rashtra Bhasa Vidyalaya including buildings already constructed as described in Schedule "A" here in after stated or will be constructed and movable properties including fixed cash fund exceeding Rs. 10,000.00 Paise (Rupees ten thousand) only with the Executive Committee shall be vested in the Trust to be utilised for the purpose and objects mentioned in clause 3 of the Memorandum of Association of the Vidyalaya. (3) That the following persons shall be the Trustees and shall hold the Trust properties described in Schedule "A" herein after stated in Trust and shall conduct the affairs of the Trust for the purpose and objects mentioned in clause 3 of the memorandum of Association of Rashtra Bhasa Vidyalaya of Jorhat.

4. That the Trust shall look after the properties and shall sanction plans and allotments of sum for further constructions or other purposes as presented by the Executive Committee.
5. That the Trust properties shall be held by the Trustees for the purpose of the Trust and none of the Trustees shall take any profit and advantage from the Trust properties.
6. That the Trust may fix a rent for the Trust properties if and when necessity arises and the rent so realised as rent shall be spent as per clause 3 of the Memorandum of association of the Vidyalaya.
7. That each of the Trustees shall remain a Trustee till death or till the age of 70 years which ever is earlier and shall Not be removed unless he resigns or is convicted in any court of law on a charge of moral turpitude or is declared of unsound mind by the Civil Surgeon of the district. or is declared insolvent.
8. That a vacancy caused for the reasons as stated in clause 4 of this Deed shall be filled in by the Executive Committee.
9. That the Trustees shall frame rules in a meeting of the Trustees for conducting their business

for the purpose of the Trust and recording the same in the proceeding (P.T.O. Continued S Murlidhar Baheti Askaran Jalan) proceeding Book signed by the Trustees attending that meeting and four Trustees shall form a quorum of all the meeting of the Trust. 10. That the Trustees shall appoint one of them as Managing Trustees. who will hold this office for (3) Three years or till the next appointment is made by the Trustees in a meeting which is later. The managing Trustees shall convene meeting keep records and documents of the Trust with him shall receive and grant receipt for donation in connection with any construction or for Trust fund and he will have all the other powers. that may be entrusted to him by the Trustees in a meeting of the Trust. 11. That in order to maintain close relation between the two bodies the Managing Trustee will be a member of the Executive committee to represent the Trust. 12. That the rules that may be framed under clause "5" of this Deed may be altered or amended by the Trustees in a meeting by at least by two third majority of the members present.

13. That every meeting of the Trust, the Chairman will be elected from amongst the members present in the meeting of the Trust. If there by a tie due to difference of opinion and when votes are taken the chairman of the meeting of the Trust by giving 7 days notice in writing (P.T.O. continued G Mulidhar Baheti Askaran Jatan)

will have a casting vote. 14. That the Managing Trustee may call a meeting of the Trust by giving 7 days notice in writing and in case if all the Trustees agree a notice may be for a shorter period. 15. That any three or more trustees may give written notice to the Managing Trustee for calling a meeting of the Trust and in that case the Managing Trustee shall call the meeting within 7 days of the receipt of the notice failing which the requisitionist Trustees may call meeting of the Trust and 7 days notice.
